

## **Data Access Request Form**

To receive a copy of your personal data held by Tullamore Credit Union, you are encouraged to submit a written request with the below information to facilitate us in accurately identifying the locations of your personal data and responding to the request as quickly as possible. The request to our Data Protection Officer should also enclose proof of Identification and Address where this has been requested. We will validate and commence working on the request once all necessary information is received.

Please note that under the Data Protection Act 2018, there are several circumstances where Tullamore Credit Union may require additional time or may be obliged to reject the legitimacy of the request or withhold certain information from disclosure. Such circumstances will be notified to the requestor where they are applicable.

Section B To help locate your personal data, please clearly state the information you require, with dates where known. Please give us as much information as possible to help us find your data. If your request is for CCTV, you must specify the exact date and time. For call recordings, please provide your phone number. Please indicate below how you would like to receive your personal data requested (please tick the box): 1. Electronic (Collection) - The files will be put on a USB and available for collection. The files will not be encrypted. You will be asked for photo ID to prove identity upon collection. Files will not be released to any person other than the Member themselves. $\square$ 2. Electronic (Email) - A link to the file will be sent by email. The files will be encrypted before sending with freely available encryption software. The encryption key will be delivered by SMS or phone call. You may be asked to prove the stated email account is your own. You should ensure that only you have access to the stated email account. $\Box$ 3. Paper Based (Collection) - Files will be printed in a format that can most easily understood. You will be asked for photo ID to prove identity upon collection. Files will not be released to any person other than the Member themselves.
