What is ESG?

ESG stands for Environmental, Social, and Governance – representing three key pillars that guide responsible, ethical and sustainable business practices.

Environmental

Tullamore Credit Union are committed to sustainability and doing everything we can to have a positive environmental impact. This includes managing our carbon footprint, optimising energy usage, reducing waste, and promoting overall environmental responsibility within our community – as well as offering 'Green' focused loans such as our Green Mortgage. The Environmental pillar of ESG is where we are the least mature, but we are no less dedicated and driven to making a significant contribution in this area.

Social

Tullamore Credit Union, and the Credit Union Sector as a whole, has a community ethos at its heart. Our strong focus in this area existed long before the term 'ESG' was coined – whether it be sponsoring community activities, donating funds to worthy causes, or participating in local events. And we have no intention of slowing down in this space! As well as the overall community, we place a strong emphasis on fostering a healthy and inclusive workplace culture, with the strong belief that happy and engaged employees are central to a successful organisation.

Governance

Good governance is at the heart of how we operate. This includes the systems and processes we have in place to govern regulatory compliance, diversity, fair pay practices, transparency, and accountability in leadership. 
Our ESG Committee

ESG Roadshow

Tullamore Credit Union, together with St Brigid's Credit Union, have launched a collaborative ECO Loan to help local homeowners invest in sustainable, energy-efficient home improvements. This joint initiative – developed in partnership with Offaly County Council's Department of Enterprise – aligns with each credit union's strategic commitment to environmental responsibility and community impact.

The new ECO Loan offers the same interest rate, terms, and conditions across all participating credit unions, providing Members with a consistent, fair, and affordable financing option for projects such as retrofitting, insulation, solar panels, and heat pumps.

This loan launch is being supported by a series of regional Energy Roadshows, where Members can meet with energy experts and credit union advisors to learn more about reducing their energy costs and environmental footprint.

This marks the first collaboration of its kind between our credit unions and reflects a shared mission to empower Members while contributing to a greener future.













Quarterly Members Prize Draw

Four cars are purchased each year from garages within our common bond which return funds to the local community. Our Staff

All Staff have attended Dignity at Work training. Dignity at Work training is a vital annual initiative that reinforces respectful conduct among employees and promotes a positive workplace culture. The training emphasises treating colleagues and Members with courtesy, fairness, and professionalism, regardless of role or background. It encourages open communication, empathy, and active listening to foster collaboration and mutual respect.

A key component of the training is understanding and complying with relevant legislation. This includes laws addressing bullying and harassment, which protect individuals from repeated, inappropriate behaviour that undermines their dignity. The training outlines clear procedures for reporting and addressing such conduct, ensuring a safe and supportive environment for all.

Participants also learn about the nine grounds of discrimination under Irish equality legislation: gender, civil status, family status, sexual orientation, religion, age, disability, race, and membership of the Traveller community. The training highlights how discrimination—whether direct or indirect—can manifest in workplace interactions and customer service and provides strategies to prevent it.

By conducting this training annually, we are reaffirming our commitment to equality, inclusion, and respect. It empowers employees to recognise unacceptable behaviour, challenge bias, and contribute to a workplace where everyone feels valued and protected. Ultimately, dignity at work is not just a policy—it's a shared responsibility.
